3. MOM Minister message at DASL Annual Dinner & Dialogue

Dormitory Association of Singapore Limited (DASL) has organised an annual dinner and dialogue on 7th February 2022 at One Farrer Hotel. Guest-of-Honour (GOH) for the event was Ministry of Manpower Minister Dr. Tan See Leng.

In the GOH speech, Minister acknowledges the effort and contribution of dormitory operators. Minister has extended his appreciation to Sungei Tengah Lodge (STL) for providing the Centralised Recovery Facilities to manage the Covid+ foreign workers. In separate discussion, he has also highlighted the importance of STL's role in the new plan, as one of the 6 sectors with more dedicated and comprehensive medical support for foreign workers living in the sector.



DASL Annual Dinner and Dialogue

4. Primary Health Care for foreign workers

MOM has revamped primary healthcare system (to be covered under the fixed cost Primary Care Plan (PCP)) for migrant workers. It is a sector-based primary healthcare system. 6 Sectors across Singapore and Sungei Tengah Lodge is Sector D designated Onsite Medical Centre (OMC) with SATA as the Anchor Operator providing:

1. Primary care services at Medical Centre for Migrant Workers
2. 24/7 telemedicine
3. Rapid response mobile clinical teams to arrest potential outbreaks within dormitories.

PCP Objectives

- A. To Employer and Employee
 1. Better health-seeking behaviours among workers leading to healthier and more productive workforce
 2. Clearer care options
 3. Better managed costs and coverage, especially for unforeseen outpatient and inpatient bills
- B. To Medical Service Providers
 1. Integrated care to meet different healthcare needs and ensure continuity of care
 2. Reduce cultural and language barriers to care
 3. Foster better doctor-patient relationships to better address care needs
- C. To Government and Partners
 1. Integrated clinical records allows better monitoring of health risks at the national level
 2. Optimise resources through early detection and intervention of care gaps.

STL is working with SATA to provide the above services and our residents will have the convenience of a one-stop onsite/in-house medical support services and a peace of mind that their medical needs are well taken care of.

5. "FWMOMCare" scan rate

MOM/ACE survey results show STL residents' poor QR code scan record and STL staff conducted a special exercise to inform all residents as well as a targeted approach against any non-compliant recalcitrant resident. All were reminded to follow the FWMOMCare apps instruction.

1. Submit health status daily
2. Scan their room QR code

To comply with FWMOMCare app is each worker's responsibilities. If work does not comply with FWMOMCare, the worker will not be allowed to go to work.

After the special effort put in, the reported 5 days rolling scan rate shows STL scan rate increase from low 55.38% & 54.86% to 92.3% & 91.66%. We thank all residents for the effort and look forward to continued effort to achieve above 95% rate target set by MOM/ACE.
