# SUNGEI TENGAH LODGE

## 1. Step Down of COVID-19 Measures

As we transit to DORSCON Green, the following measures will take effect from **1 March 2023** in Sungei Tengah Lodge

<b>Removal of block segregation barriers in dormitories</b>	<ul style="list-style-type: none"> <li>• Dormitories <b>will no longer be required to implement block segregation barriers</b> within the dormitories.</li> </ul>
<b>Removal of Popular Places Pass</b>	<ul style="list-style-type: none"> <li>• MWS <b>visiting Chinatown, Geylang Serai, Jurong East and Little India will no longer need to apply for passes</b> on any day of the week.</li> </ul>
<b>Access Code status</b>	<ul style="list-style-type: none"> <li>• MWS can leave their residence for work regardless of their AccessCode colour status. AccessCode status will be set to green by default.</li> <li>• Dormitory operators and employers will no longer need to check the MWS' AccessCode status when they wish to leave their residence.</li> </ul>
<b>Removal of requirement to scan QR code in dormitory room</b>	<ul style="list-style-type: none"> <li>• MWS <b>will not need to scan the QR code</b> in their dormitory rooms.</li> </ul>

**Note:** MWS with ARI should recover in their own rooms while wearing their masks. MWS who are feeling unwell should continue to seek medical treatment at the MCMWS or via telemedicine.

## 2. Talk to MOM

We encourage our resident facing any problem, can use the **“Talk to MOM”** function on FWMOMCare and MOM officer will contact you within 3 days (excluding weekends and public holidays) after you have submitted the request.

Log into FWMOMCare and look for the icon **“Talk to MOM”** on the home page.



## 2. Room Checks

Our operation team conducts randomly room checks and reported some observation and need to make good.

**1. Description:** No luggage on top of the locker near the window.

**Reason:** People downstairs at ground level have the risk of falling object.



**2. Description:** Things like clothes, buckets, bottles, multi-sockets etc. lying in the center common area are not allowed.

**Reason:** During fire/ black-out, fleeing residents will trip over the obstacles



**3. Description:** No Smoking, alcohol and meals consumption. No Cooking utensils, knives and sharp objects in the room.

**Reason:** Hygiene, pest control and good living condition in room and to avoid use of sharp objects in case of fights.



**4. Description:** No Hanging of clothes/sarong on sprinkler pipe and bed and poles are not allowed. Fully covered bed space with sarong, cloth and hanged clothes are not allowed

**Reason:** Sprinkler pipes not designated to carry weight of hanging clothes. SCDF do not allow fully covered bed space. Affect visual checks and evacuation.



**5. Description:** Prohibited Electrical appliances.

**Reason:** Safety Hazard. Fan doesn't have safety cover.



**6. Description:** Extension wire together with multi-electrical sockets on bed and table fan on bed are not allowed.

**Reason:** Safety Hazard because of risk of electrocution.
